**ARTICLES OF INCORPORATION**  
**OF**  
**VIRGINIA BORDER COLLIE ASSOCIATION, INC.**

We hereby associate and form a non-stock corporation under the provisions of Chapter 1. of Title 13.1 of the Code of Virginia, 1950, as amended, and to that end set forth the following:

1. The name of the corporation is Virginia Border Collie Association, Inc.
2. The purpose of the corporation is to transact any or all lawful business not required to be specifically stated in the Articles of Incorporation for which a corporation may be incorporated under this act.
3. The corporation is to have the following classes of members:
  - a. In State Members consisting of adults who resides within the Commonwealth of Virginia.
  - b. Out of State Members consisting of adults who reside outside the Commonwealth of Virginia.
  - c. Junior Members consisting of in state and out of state members under the age of eighteen.
4. The directors of the corporation shall be elected by a majority vote of participating members. Junior Members do not have the right to participate in the election of directors. Directors shall serve terms of one year. To be qualified to serve as a director the person must be a Virginia member in good standing.
5. The corporations initial registered office address is Route 2, Box 540, Madison, Virginia, 22727. The initial office is located in the County of Madison in the Commonwealth of Virginia.
6. The name of the initial registered agent, whose business address is identical with the above registered office, is Leighton Brown.

7. The initial registered agent is a resident of Virginia and an initial director of the corporation.

8. This is a non-stock, non-profit corporation whose principal goal is to encourage the use, ownership, breeding, care and enjoyment of the breed of dog designated as a Border Collie. To facilitate this overriding purpose, the corporation reserves unto itself all powers and authorities normally and legally granted to all corporations incorporated in the Commonwealth of Virginia, specifically including those set forth in Section B.1-826 of the Code of Virginia, 1950.
